Overall purpose of the job:

This is an exciting opportunity to join our Operations Team and take the lead on a range of ambitious catchment restoration initiatives. We're looking for 2 x Catchment Restoration Officer posts; one based in the Severn Vale catchment and one based in the Teme catchment. Both positions will require experienced and enthusiastic individuals, capable of effective project management.

As a Catchment Restoration Officer, you will be required to develop proposals, appoint and manage contractors, control budgets and oversee the delivery of several projects concurrently. To achieve this, you will work closely with many of our key stakeholders and partners, fostering strong working relationships to facilitate the smooth delivery of capital works and establish SRT as the 'go-to' environmental organisation.

Importantly, you will work collaboratively as part of a wider team, to ensure the correct support, knowledge and experiences are being leveraged to deliver at a consistently high standard. Where additional support is needed, you will procure and oversee a diverse portfolio of skilled contractors, to deliver the proposed works to the same high standards.



Alongside capital delivery, you will ensure a robust monitoring program is established and delivered to capture the impacts of your restoration work. At SRT, we take particular care to ensure all our projects include a considered monitoring plan to guide project reporting and the wider restoration community. Furthermore, Catchment Restoration Officers take the lead on their respective catchment partnerships. This duty focuses on establishing long lasting, prosperous relationships for stakeholders throughout the catchment. Through this, the partnership facilitates project collaboration and ensures a 'bigger, better, more joined up' approach to project delivery.

About Severn Rivers Trust

The River Severn is longest river in the United Kingdom, stretching 220 miles from its source in the Cambrian Mountains in Powys Wales, through the counties of Shropshire, Worcestershire and into Gloucestershire to the iconic estuary. The culture and economies of the historic settlements across the catchment have been intertwined with the river through commercial navigation, fishing, water supply and trade. Today, the Severn's rivers continue to play an essential role in supporting wildlife, wellbeing and economies of the region.

A closer look at our work in the Severn Vale & Teme catchments

Severn Vale

The Severn Vale forms the crossroads of the Severn Estuary SAC and the UKs longest, and one of the most diverse, river systems. Within the Severn Vale we are currently engaged in several very ambitious projects looking to preserve and enhance this lowland oasis. Our projects are primarily focused on improving fish passage potential, In-channel and offline wet habitat creation and catchment management initiatives. The Catchment Restoration Officers (Severn Vale) primary deliverable will be our Cinderford Brook Restoration Project. We are fast approaching the delivery phase of this project, whereby the successful candidate will deliver our impactful programme of in-channel & catchment-based capital works. Deliverables will include; in-channel substrate suppletion, LWD installation, wetland creation and low flow resilience measures. Collectively, these interventions will deliver multiple benefits centred around enhancing the ecological resilience to the issues associated with low flows.

Teme

The River Teme (SSSI) is the jewel in the Severn's crown, hosting some of the country's most diverse habitats and species of critical importance. We have a landscape defining package of works ongoing within the Teme and it is time to deliver even more. This role will be focused on the delivery of natural flood management (NFM) alongside wider habitat creation and restoration initiatives. Importantly, you will be working with landowners throughout the catchment to identify and deliver projects that promote and ensure Biodiversity Net Gain (BNG). You will also support on our Woodland creation programmes within the Teme Catchment, helping contribute towards our ambitious goal of creating or restoring 300 hectares of new riparian woodlands throughout the Severn catchment.

Like all Catchment Restoration Officers, you will have the autonomy to develop new projects that deliver against our wider strategic objectives, such as wetland creation, farmland habitat creation and fish passage improvements.

Role Requirements



Project management

- Prepare work programmes for assigned projects to ensure the effective delivery and smooth running of an agreed programme of restoration interventions.
- Prepare and adhere to delivery programs with pre-agreed milestones. Ensure the effective management of resources and decisively deploy appropriate delivery mechanisms to carry out capital works, e.g. external contractors, volunteer groups, staff etc.
- Plan and oversee the delivery of capital works, ensuring best practice and high standards are consistently achieved
- Effectively manage and prioritise work programs to ensure project deliverables are met within the project timeframes
- Manage delegated project budgets to ensure expenditure remains on track and within the allocated budget
- Liaise with and report back to the funder via clear, concise reports and presentations on the progress of the project

Landowner engagement & project delivery

- Grow the Trust's presence and credibility within the catchment, focusing attention on preagreed priority areas.
- Work closely with landowners in the catchment to explain your projects, gain their trust, ensure their buy-in and ultimately deliver the project objectives on third part sites
- Provide sound professional advice to landowners on a range of environmental priorities including; natural flood management, habitat creation, restoration & management, water quality and sustainable agricultural practices
- Design and oversee the installation of land and riverine management interventions that contribute to the above environmental priorities
- Proactively promote allocated projects, and foster landowner support for their delivery
- Keep up to date with evolving environmental regulations and support opportunities that will shape the British countryside.

Catchment Partnership

• Take the lead on driving forward the development of your local Catchment Partnership through regular meetings and development of projects with partners.



- Support partners in the development of new, innovative project ideas that will deliver against key priorities in the catchment.
- Provide end-to-end support to refine ideas into market-ready projects and identify Project Sponsors, who will lead project delivery, at the point of inception.
- Inspire and engage stakeholders with different agendas and priorities to 'think big' and work together to enhance and protect our water environments.
- Champion the Severn & Teme CaBA Partnerships internally and externally, to raise awareness of the approach and demonstrate how it is being used to deliver catchment scale restoration.

Sustainable funding

- Manage delegated projects and associated budgets, ensuring value for money is achieved by the Trust and any supporting partners
- Support the finance team in making financial claims for delegated projects, ensuring all records are accurate and required evidence is provided in a timely manner
- Work with the Trust's management team to seek external grant funding & private finance opportunities to support the delivery of our objectives.

Other Duties

- Forge strong working relations and establish SRT as the 'go-to' delivery partner with a range of organisations, most notably including the Environment Agency, Severn Trent Water, Natural England & Local Authorities
- Where necessary, mentor junior colleagues and share knowledge throughout the Trust
- You shall lead by example in prioritising health and safety and wellbeing by taking responsibility for yourself, participants, volunteers, and colleagues
- You shall always comply with Severn Rivers Trust's Health & Safety and Safeguarding policies and defined standards of behaviour
- You may be required to carry out other duties and tasks as required from time to time for the efficient operation of the Trust.
