

## **Role Summary**

Job title:	Ecosystems Services Lead
Location of job:	Hybrid working – home based with travel requirements throughout the catchment.

#### **Overall purpose of the job:**

Funding for the environmental sector is evolving and here at SRT we are adapting our ways of working accordingly. An opportunity now exists to address the funding gap that has plagued our sector for too long, by means of pursuing alternative private sector funding avenues. This position will be fundamental to helping our organisation do just that and achieving our ambitious plans for catchment wide ecological restoration.

You will work closely with our Head of Development to provide the technical support and understanding of natural capital markets, necessary for the development of new lines of services in respect to Carbon Offsetting, Biodiversity Offsetting and Natural Flood Management investment.

Additionally, you will work with our Operations Team, supporting them in their work to develop ecosystem service models, that help appraise the ecological and financial value of landscape interventions. Alongside our GIS & Data Officer, you will advise on what data we gather, how we collect it and identify external stakeholders and partners that can provide wrap around support and fill internal knowledge gaps.

Importantly, you will have the autonomy to use your natural flare for innovation to pursue new opportunities, test their viability and integrate them into our delivery approach.





# About Severn Rivers Trust

The River Severn is longest river in the United Kingdom, stretching 220 miles from its source in the Cambrian Mountains in Powys Wales, through the counties of Shropshire, Worcestershire and into Gloucestershire to the iconic estuary. The culture and economies of the historic settlements across the catchment have been intertwined with the river through commercial navigation, fishing, water supply and trade. Today, the Severn's rivers continue to play an essential role in supporting wildlife, wellbeing and economies of the region.

## **Role Requirements**

## **Business development**

- Support in developing and refining our portfolio of environmental services and establishing Severn Rivers Ecology in the ecological consultancy marketplace
- Support in negotiating contracts of sale for ecosystem services (e.g., through the sale of biodiversity units sold to developers, or carbon credits sold to businesses seeking to offset their carbon emissions)
- Establishing strategic partnerships with businesses and organisations capable of offering wrap around support, or complementary services, to our own activities

## **Technical support**

- Technical support to our Operations Team, in the development of natural capital models to appraise the ecological, and associated fiscal benefits, of our work. The following two models are currently in development;
  - *Farm Hydrology Model,* intending to quantify the role good soil husbandry and farmyard rainwater harvesting can have on reducing flood risk and improving water quality
  - *Natural Flood Management investment model*, intending to quantify the role 'traditional' NFM interventions can have at a farm scale.
- Lead on developing our organisations approach to surveying and monitoring, helping establish template survey procedures that enable our catchment staff to collect the information that is necessary for undertaking biodiversity metric calculations and other natural capital assessments
- Alongside our GIS & Data Officer, undertake biodiversity metric calculations, and other natural capital evaluations, using data provided by the team
- Act as an advocate for new environmental markets within the Trust, helping explain key concepts to the wider team

## **Project management**

- End to end project management of discrete work programmes, ensuring effective time and resource management in order to meet project outputs within the required timeframe
- Manage delegated project budgets to ensure income and expenditure remains on track
- Liaise with and report back to the funder via clear, concise reports and presentations on the progress of the project



## **Other Duties**

- Forge strong working relations with partners and businesses to establish SRT as the 'go-to' environmental delivery partner
- Where necessary, mentor junior colleagues and share knowledge throughout the Trust
- You shall lead by example in prioritising health and safety and wellbeing by taking responsibility for yourself, participants, volunteers, and colleagues
- You may be required to carry out other duties and tasks as required from time to time for the efficient operation of the Trust.
