The Government of the Republic of Uzbekistan has received an investment grant from the Asian Infrastructure Investment Bank (AIIB) to finance the costs of developing the Project “Development and modernization of the drinking water supply and sewerage system of the Khorezm region and the Republic of Karakalpakstan”. At the same time, the Government of the Republic of Uzbekistan intends to allocate part of the grant funds for consulting services for further technical preparation of the project according to the “General procurement notice” dated July 14, 2021. The technical preparation includes hiring an Individual Consultant (International Specialist) to carry out economic and financial analysis for water and sanitation activities in the Republic of Karakalpakstan.

Consulting services include carrying out the financial and economic analysis of the overall Project in coordination with AIIB and JSC “Uzsuvtaminot”. The analysis should be conducted and presented such that it provides the overall results for the project and individually for the Republic of Karakalpakstan. This requires close coordination with the economic and financial consultant preparing the assessment for the other region. The consultant's Terms of Reference contain all information about the consultant's responsibilities and is available at the address below.

The method of selection is Individual Consultant Selection in accordance with the AIIB Policy and Procurement Instructions for Recipients. It is expected that the contract will be concluded in first quarter of 2023, and will be completed within 90 days of intermittent input till the completion of the Feasibility Study assignment.

JSC “Uzsuvtaminot”, as an Implementing Agency, invites competent Individual Consultants to submit application letters and comprehensive curriculum vitae reflecting their qualifications to achieve minimum qualification and experience requirements, in particular:

- I. Must have at least a relevant Master's degree (Economics, Engineering or similar);
- II. Must have ten (10) years of experience in economic and financial analysis, in two or more countries, preferably in the Water and Sanitation sector;
- III. Experience of at least 5 years in Multilateral Development Bank (MDB) funded projects;

- IV. Good knowledge of English and Uzbek and/or Russian is desired;
- V. Consultant must have the ability to: i) handle multiple tasks under pressure with short deadlines; (ii) ability to work independently, seeking guidance on complex issues; and (iii) excellent interpersonal skills, proven team orientation and the ability to work across unit boundaries.
