#### Overall purpose of the job

In 2022, Wetlands International Europe, partnering with the IUCN, World Fish Migration Foundation, and UNEP WCMC, launched the <u>Trans-European Swimways Network</u> as a visible flagship to protect migratory freshwater fishes in Europe. This Network is working to address the alarming loss of migratory freshwater fishes in Europe, building on the extensive experience of the flyway conservation approach to migratory waterbirds, in order to foster international and cross-sector cooperation. It will also improve scientific knowledge and guidance to strengthen EU policies and help shape new policies such as the proposed Nature Restoration Law to ensure effective river and habitat restoration. In 2023, the <u>Trans-European Swimways Programme</u> was released, and work began on developing Swimways of European Importance (SEI) based on the best available data.

The Swimways Technical Project Assistant will support the development of SEI and the identification of key restoration opportunities. The intern will create useful outputs from this data analysis and map SEI in order to inform policy recommendations to European countries and the European Commission.

#### Roles and responsibilities

The Swimways Technical Project Assistant will support Wetlands International Europe's team in carrying out the actions of the Trans-European Swimways Programme, by carrying out literature reviews, data gathering, data management, and analyses.





Supporting roles and responsibilities may include:

#### 1. Identify Swimways of European Importance

- assisting the project team in developing criteria to identify SEI based on the draft global Swimways criteria,
- applying criteria against the existing species occurrence, economics, and recreational data,
- conducting literature searches on SEI,
- analysing and mapping SEI to create various useful outputs for decision-makers,
- identifying key restoration opportunities for breeding or feeding habitats required for population recovery.

#### 2. Identify critical barriers on SEI

- reviewing the status of barrier inventories in the EU and identifying gaps,
- identifying critical barriers impeding fish migration or reducing spawning in the EU,
- identifying river sections with threatened migratory species currently protected from alien species by barriers.

### 3. Develop knowledge on fish passes

- conducting a literature search on the efficacy of fish passes,
- producing a policy briefing on the topic to promote effective solutions for fish migration.

### **Internship Offer**

- Only applicable to students. His/her educational institute should be able to provide an Internship agreement to be signed among the three parties.
- Part time or full-time (full time =36 hrs/week).
- Reimbursement of a maximum of 450 EUR/month, based on 36 hour week. The Intern will be asked to register hours and submit a monthly expense claim.
- Contract duration: minimum of 6 months





- Location: Remote working, but based in Belgium/The Netherlands The Intern should be willing to work occasionally from the office and attend meetings in Brussels and/or Ede (NL).
- Start date: January 2024
