5 Project Background

Basic sanitation access in South Sulawesi has achieved 92,24% in 2022. However, only 8% of the population in the province has access to safely managed sanitation (Ministry of National Development Planning/Bappenas: Bappeda (Provincial Planning Agency), South Sulawesi, 2024). The Government's priority as stated in the RPJMN 2020-2024 is to achieve at least 90% basic sanitation, including 20% safe sanitation. Therefore, improving the quality of sanitation access also needs to be prioritized, to also ensure that indicators of SDGs related to safely managed sanitation are achieved. South Sulawesi is currently achieving ODF province status, so the urgent demand to accelerate sustainable and safely managed sanitation coverage is a priority. The need to provide access to safely managed sanitation services is being socialized as a right for all residents. At the same time, climate resilience adaptation issues for water, sanitation

and hygiene need to be included in local district planning documents to ensure the sustainability of WASH services. South Sulawesi province's strategic position to accelerate the progress both in total sanitation and safely managed sanitation is underlined through the provision of knowledge products and learning platforms. A number of prioritized initiatives have been agreed upon with provincial and districts governments and CSO partners as a form of strategic intervention in the WASH development sector. The initiatives will certainly be implemented inclusively by involving WASH development stakeholders, starting from the cooperation of universities and health schools, housing developers, media, coordination platform within the governments (Pokja PKP), and communities. The initiative targets the implementation of strong collaboration at the district to village level led by human resources who have a good understanding of the implementation of safely managed sanitation. UNICEF is supporting the provincial government to accelerate the adoption and coverage of safely managed sanitation. The intervention strategy is: - to enhance the province's role as a knowledge broker to districts to increase the capacity of stakeholders, - utilize the available budgets more effectively and formulate evidence-based policy to achieve the specified targets, through knowledge documentation and sharing, horizontal learning, and assisted coaching. - Facilitate effective cooperation of key stakeholders with a better understanding on safely managed sanitation services supported by active participation from universities, schools of health, and the private sector (housing developers). The proposed interventions are in line with 2021-2025 UNICEF Country Programme Action Plan (CPAP), under Output 2.1 (Safely managed sanitation).

6 Expected Results

The expected result of this partnership is divided into several areas, outputs, and activities: 1) Provincial government has capacity to support selected districts in improving the service provisions and in increasing public demand on safely managed sanitation (related to AWP Input Activity 2.1.1.2) Key activities: • Mentoring for institutional strengthening for domestic wastewater operators (UPT PALD) and technical assistance on faecal sludge desludging and treatment at IPLT. • Collaboration with local media (TV, print, and online) and facilitation on creating features to promote safely managed sanitation for public. 2) Provincial government has capacity on supporting the districts to strengthen monitoring system and inspection tools for on-site sanitation of households in South Sulawesi province (related to AWP Input Activity 2.1.2.2) Key activities: • Survey and inspection of household domestic wastewater facilities, in collaboration with sanitarians, sanitarian candidates (students of POLTEKKES), and UPT PALD enumerators, feeding to customer data for UPT PALD in 2 districts. The Result Framework matrix attached (in the end of the document) provides detail outputs, the location coverage, the indicators to measure the output achievement, including the baseline data and targets for each indicator, and the means of verification.
