3.2. Please email the IUCN contact to express your interest in submitting a Proposal by the deadline stated above. This will help IUCN to keep you updated regarding the procurement.

4. COMPLETING AND SUBMITTING A PROPOSAL

- 4.1. Your Proposal must consist of the following four separate documents:
 - Signed Declaration of Undertaking (see Attachment 2)
 - Pre-Qualification Information (see Section 4.3 below)
 - Technical Proposal (see Section 4.4 below)
 - Financial Proposal (see Section 4.5 below)

Proposals must be prepared in Vietnamese and summary in English.

4.2. Your Proposal must be submitted by email to the IUCN Contact (see Section 2). The subject heading of the email shall be [RfP Reference – bidder name]. The bidder name is the name of the company/organisation on whose behalf you are submitting the Proposal, or your own surname if you are bidding as a self-employed consultant. Your Proposal must be submitted in PDF format. You may submit multiple emails suitably annotated, e.g. Email 1 of 3, if attached files are too large to suit a single email transmission. You may not submit your Proposal by uploading it to a file-sharing tool.

IMPORTANT: Submitted documents <u>must be password-protected</u> so that they cannot be opened and read before the submission deadline. Please use the same password for all submitted documents. <u>After</u> the deadline has passed and within 12 hours, please send the password to the IUCN Contact. This will ensure a secure bid submission and opening process. Please DO NOT email the password before the deadline for Proposal submission.

4.3. *Pre-Qualification Criteria*

IUCN will use the following Pre-Qualification Criteria to determine whether you have the capacity to provide the required goods and/or services to IUCN. Please provide the necessary information in a single, separate document. Bidders who bid for both lots need to submit the pre-qualification information only once.

Pre-Qualification Criteria

- (1) Has 3 relevant references of clients similar to IUCN or completed similar work
- (2) Firms and organizations bidders should verify that they have all necessary legal
- registrations and certifications to to perform the work

4.4. Technical Proposal

The Technical Proposal must address each of the criteria stated below explicitly and separately, quoting the relevant criteria reference number (left-hand column).

Proposals in any other format will significantly increase the time it takes to evaluate, and such Proposals may therefore be rejected at IUCN's discretion.

Where CVs are requested, these must be of the individuals who will actually carry out the work specified. The individuals you put forward may only be substituted with IUCN's approval.

4.5. Financial Proposal

- 4.5.1. The Financial Proposal must be a fixed and firm price for the provision of the goods/services stated in the RfP in their entirety.
- 4.5.2. *Prices include all costs*

Submitted rates and prices are deemed to include all costs, insurances, taxes (except VAT, see below), fees, expenses, liabilities, obligations, risk and other things necessary for the performance of the Terms of Reference or Specification of Requirements. IUCN will not accept charges beyond those clearly stated in the Financial Proposal. This includes applicable withholding taxes and similar. It is your responsibility to determine whether such taxes apply to your organisation and to include them in your Financial Proposal.

4.5.3. Applicable Goods and Services Taxes

Proposal rates and prices shall be exclusive of Value Added Tax.

- 4.6. Additional information not requested by IUCN should not be included in your Proposal and will not be considered in the evaluation.
- 4.7. Your Proposal must remain valid and capable of acceptance by IUCN for a period of 90 calendar days following the submission deadline.

4.8. Withdrawals and Changes

You may freely withdraw or change your Proposal at any time prior to the submission deadline by written notice to the IUCN Contact. However, in order to reduce the risk of fraud, no changes or withdrawals will be accepted after the submission deadline.

5. EVALUATION OF PROPOSALS

5.1. Completeness

IUCN will firstly check your Proposal for completeness. Incomplete Proposals will not be considered further.

5.2. Pre-Qualification Criteria

Only Proposals that meet all of the pre-qualification criteria will be evaluated.

5.3. Technical Evaluation

5.3.1. Scoring Method

Your Proposal will be assigned a score from 0 to 10 for each of the technical evaluation criteria, such that '0' is low and '10' is high.

5.3.2. *Minimum Quality Thresholds*

Proposals that receive a score of '0' for any of the criteria will not be considered further.

5.3.3. Technical Score

Your score for each technical evaluation criterion will be multiplied with the respective relative weight (see Section 4.4) and these weighted scores added together to give your Proposal's overall technical score.

5.4. Financial Evaluation and Financial Scores

The financial evaluation will be based upon the full total price you submit. Your Financial Proposal will receive a score calculated by dividing the lowest Financial Proposal that has passed the minimum quality thresholds (see Section 5.3.2) by the total price of your Financial Proposal.

Thus, for example, if your Financial Proposal is for a total of CHF 100 and the lowest Financial Proposal is CHF 80, you will receive a financial score of 80/100 = 80%

5.5. Total Score

Your Proposal's total score will be calculated as the weighted sum of your technical score and your financial score.

The relative weights will be:

Technical:	<mark>70%</mark>
Financial:	<mark>30%</mark>

Thus, for example, if your technical score is 83% and your financial score is 77%, you will receive a total score of 83 * 70% + 77 * 30% = 58.1% + 23.1% = 81.2%.

Subject to the requirements in Sections 4 and 7, IUCN will award the contract to the bidder whose Proposal achieves the highest total score.

6. EXPLANATION OF PROCUREMENT PROCEDURE

- 6.1. IUCN is using the Open Procedure for this procurement. This means that the contracting opportunity is published on IUCN's website and open to all interested parties to take part, subject to the conditions in Section 7 below.
- 6.2. You are welcome to ask questions or seek clarification regarding this procurement. Please email the IUCN Contact (see Section 2), taking note of the deadline for submission of questions in Section 3.1.
- 6.3. All Proposals must be received by the submission deadline in Section 3.1 above. Late Proposals will not be considered. All Proposals received by the submission deadline will be evaluated by a team of evaluators in accordance with the evaluation criteria stated in this RfP. No other criteria will be used to evaluate Proposals. The contract will be awarded to the bidder whose Proposal received the highest Total Score. IUCN does, however, reserve the right to cancel the procurement and not award a contract at all.
- 6.4. IUCN will contact the bidder with the highest-scoring Proposal to finalise the contract. We will contact unsuccessful bidders after the contract has been awarded and provide detailed feedback. The timetable in Section 3.1 gives an estimate of when we expect to have completed the contract award, but this date may change depending on how long the evaluation of Proposals takes.

7. CONDITIONS FOR PARTICIPATION IN THIS PROCUREMENT

- 7.1. To participate in this procurement, you are required to submit a Proposal, which fully complies with the instructions in this RfP and the Attachments.
 - 7.1.1. It is your responsibility to ensure that you have submitted a complete and fully compliant Proposal.
 - 7.1.2. Any incomplete or incorrectly completed Proposal submission may be deemed noncompliant, and as a result you may be unable to proceed further in the procurement process.
 - 7.1.3. IUCN will query any obvious clerical errors in your Proposal and may, at IUCN's sole discretion, allow you to correct these, but only if doing so could not be perceived as giving you an unfair advantage.
- 7.2. In order to participate in this procurement, you must meet the following conditions:
 - Free of conflicts of interest
 - Registered on the relevant professional or trade register of the country in which you are established (or resident, if self-employed)
 - In full compliance with your obligations relating to payment of social security contributions and of all applicable taxes
 - Not been convicted of failing to comply with environmental regulatory requirements or other legal requirements relating to sustainability and environmental protection
 - Not bankrupt or being wound up
 - Never been guilty of an offence concerning your professional conduct
 - Not involved in fraud, corruption, a criminal organisation, money laundering, terrorism, or any other illegal activity.
- 7.3. You must complete and sign the Declaration of Undertaking (see Attachment 2).
- 7.4. If you are participating in this procurement as a member of a joint venture, or are using subcontractors, submit a separate Declaration of Undertaking for each member of the joint venture and sub-contractor, and be clear in your Proposal which parts of the goods/services are provided by each partner or sub-contractor.
- 7.5. Each bidder shall submit only one Proposal, either individually or as a partner in a joint venture. In case of joint venture, one company shall not be allowed to participate in two different joint ventures in the same procurement nor shall a company be allowed to submit a Proposal both on its behalf and as part of a joint venture for the same procurement. A bidder who submits or participates in more than one Proposal (other than as a subcontractor or in cases of alternatives that have been permitted or requested) shall cause all the Proposals with the bidder's participation to be disgualified.
- 7.6. By taking part in this procurement, you accept the conditions set out in this RfP, including the following:
 - It is unacceptable to give or offer any gift or consideration to an employee or other representative of IUCN as a reward or inducement in relation to the awarding of a contract. Such action will give IUCN the right to exclude you from this and any future procurements, and to terminate any contract that may have been signed with you.
 - Any attempt to obtain information from an employee or other representative of IUCN concerning another bidder will result in disqualification.
 - Any price fixing or collusion with other bidders in relation to this procurement shall give IUCN the right to exclude you and any other involved bidder(s) from this and any future procurements and may constitute a criminal offence.

8. CONFIDENTIALITY AND DATA PROTECTION

- 8.1. IUCN follows the European Union's General Data Protection Regulation (GDPR). The information you submit to IUCN as part of this procurement will be treated as confidential and shared only as required to evaluate your Proposal in line with the procedure explained in this RfP, and for the maintenance of a clear audit trail. For audit purposes, IUCN is required to retain your Proposal in its entirety for 10 years after then end of the resulting contract and make this available to internal and external auditors and donors as and when requested.
- 8.2. In the Declaration of Undertaking (Attachment 2) you need to give IUCN express permission to use the information you submit in this way, including personal data that forms part of your Proposal. Where you include personal data of your employees (e.g. CVs) in your Proposal, you need to have written permission from those individuals to share this information with IUCN, and for IUCN to use this information as indicated in 8.1. Without these permissions, IUCN will not be able to consider your Proposal.

9. COMPLAINTS PROCEDURE

10. CONTRACT

Attachment 1. Terms of reference

Investigation, survey and additional assessment of the biodiversity, fisheries resources, socio-economic conditions, and environment to identify potential areas for establishing the other effective conservation measures (OECMs) in Kien Giang Province

I. Background

The Mekong Delta Coastal Habitat Conservation (MDC), funded by the U.S. Government through the United States Agency for International Development (USAID) in Vietnam, will collaborate with Vietnamese government agencies, local authorities, businesses, management boards, development partners, and fishing communities to mitigate threats to biodiversity and fishery resources while enhancing the resilience of coastal ecosystems in the Mekong Delta. The project will be implemented in vulnerable coastal areas of the Mekong Delta (Soc Trang), Phu Quoc Marine Protected Area, and three small island clusters in the southwestern sea: Ha Tac, Ba Lua, Nam Du (Kien Giang). The project will implement comanagement models for fishery resources, support business participation in Phu Quoc Marine Protected Area, conduct studies for sustainable marine resource management, and encourage investment in marine ecosystem and biodiversity conservation. The project will also support cooperation between fishing communities and local authorities to manage and conserve biodiversity in the three island clusters while seeking and testing solutions to conserve and expand mangrove forests behind sea dikes, which serve as spawning, nursery, and feeding grounds for valuable fishery species and marine biodiversity.

In addition to officially protected areas, Other Effective Conservation Measures (OECMs) have emerged as a potential solution for biodiversity conservation. Although conservation may not be the primary objective, OECMs can, through appropriate measures, protect biodiversity as a long-term "additional benefit." According to the Convention on Biological Diversity (CBD), OECMs are clearly defined areas that are not part of the protected area system, managed to achieve long-term biodiversity conservation effectiveness, maintain ecosystem functions, and conserve cultural, spiritual, socio-economic, and local values. The OECM approach is increasingly emphasized, especially as the world moves towards the "30x30" goal, which aims to convert 30% of land and sea areas into protected areas by 2030. Vietnam has only designated about 7% of land area and less than 1% of marine area as protected. CBD and IUCN have outlined four criteria that OECMs must meet:

- The area is not currently recognized as a protected area.
- The area is governed and managed.
- It contributes sustainably and effectively to in situ biodiversity conservation.
- It has ecosystem functions and services linked to cultural, spiritual, socio-economic, and other relevant local values.

Kien Giang is a province with high biodiversity and many potential areas that meet the criteria to become OECMs. In addition to terrestrial ecosystems, Kien Giang's marine ecosystems, especially in coastal island areas, have potential. However, most of these areas are not yet managed and protected formally. Therefore, there is a need to compile and study potential OECM areas in the coastal and island regions of Kien Giang and digitize potential OECM options on GIS maps.

The MDC project seeks a team of experts to compile and assess various aspects of biodiversity, fishery resources, economic-social conditions, and environmental factors in Kien Giang's marine areas to identify potential areas suitable for listing as OECMs.

2. Objectives

Identify a list of potential areas for establishing Other Effective Conservation Measures (OECMs) in Kien Giang.

3. Scope of Work

- Research and compile existing data on biodiversity, fishery resources, socio-economic conditions, and map potential OECM areas in the coastal region of Kien Giang.
- Investigate, survey, and assess the current status of biodiversity, fishery resources, economic-social conditions, and environment in Kien Giang.
- Organize stakeholder consultation workshops to identify a list of potential areas for OECMs and propose a list of OECMs with appropriate management methods for Kien Giang Province.

4. Deliverables

- 1. **Inception Report**: Including approach, research methods, data collection and processing tools, detailed work plan, team member assignments, stakeholder coordination, and key milestones.
- 2. **Final Report**: Including a list of potential areas for establishing OECMs with suitable management methods in Kien Giang.
- 3. Summary Report in Vietnamese and translated into English: Covering the research process (including field reports).
- 4. Survey Data and Other Related Documents.

Note: The deliverables of the assignment will be handed over to the Department of Agriculture and Rural Development of Kien Giang Province upon acceptance.

5. Timeline

The work is expected to be completed within 4 months from the contract signing date.

I. Bối cảnh

Dự án Bảo vệ Hệ sinh thái ven biển vùng đồng bằng sông Cửu Long (MDC), được tài trợ bởi Chính phủ Hoa Kỳ thông qua Cơ quan Phát triển quốc tế Hoa Kỳ tại Việt Nam (USAID), sẽ hợp tác cùng các cơ quan chính phủ Việt Nam, chính quyền địa phương, các doanh nghiệp, ban quản lý, các đối tác phát triển và cộng đồng ngư dân nhằm giảm thiểu các mối đe dọa đối với đa dạng sinh học và nguồn lợi thủy sản, đồng thời tăng cường sức chống chịu cho hệ sinh thái ven biến vùng Đồng bằng sông Cửu Long. Dự án sẽ được triển khai tại các vùng bờ biển dễ bị tổn thương của đồng bằng sông Cửu Long (Sóc Trăng), Khu bảo tồn biển Phú Quốc và ba cụm đảo nhỏ ở vùng biển Tây Nam , Hải Tặc, Bà Lụa, Nam Du, (Kiên Giang). Dự án sẽ thực hiện các mô hình đồng quản lý nguồn lợi thủy sản, hỗ trợ sự tham gia của doanh nghiệp tại Khu bảo tồn biển Phú Quốc, và thực hiện các nghiên cứu để quản lý bền vững tài nguyên biển, đồng thời thúc đẩy doanh nghiệp đầu tư vào bảo tồn hệ sinh thái biển và đa dạng sinh học. Dự án cũng sẽ hỗ trợ hợp tác giữa cộng đồng ngư dân và chính quyền địa phương để quản lý bảo tồn đa dạng sinh học ở ba cụm đảo, đồng thời tìm kiếm và thử nghiệm các giải pháp để bảo tồn và mở rộng diện tích rừng ngập mặn phía trong hệ thống đê biển, là bãi giống bãi đẻ, bãi ương nuôi cho các loài thủy sản có giá trị và đa dạng sinh học biển.

Bên cạnh hệ thống khu bảo tồn chính thức, các Khu vực có Hiệu quả Bảo tồn khác (OECMs) nổi lên như một giải pháp tiềm năng cho việc bảo tồn đa dạng sinh học. Cho dù bảo tồn không phải là mục tiêu chính, nhưng thông qua các biện pháp phù hợp, OECMs có thể bảo vệ đa dạng sinh học như một "lợi ích cộng thêm" lâu dài. Theo Công ước Đa dạng Sinh học (CBD), OECMs là những khu vực được xác định rõ ràng, không thuộc hệ thống khu bảo tồn, được quản lý để đạt hiệu quả bảo tồn đa dạng sinh học bền vững, duy trì chức năng hệ sinh thái, đồng thời bảo tồn các giá trị văn hóa, tinh thần, kinh tế xã hội và địa phương. Cách tiếp cận OECMs ngày càng được chú trọng, đặc biệt trong bối cảnh thế giới đang hướng đến mục tiêu "30x30", chuyển đổi 30% diện tích đất liền và biển thành khu bảo tồn vào năm 2030 và Việt Nam mới chỉ quy hoạch khoảng 7% diện tích đất liền và chưa đến 1% diện tích biển thành khu bảo tồn. CBD và IUCN đã vạch ra 4 tiêu chí mà các khu OECMs cần đáp ứng:

- Khu vực hiện chưa được công nhận là một khu bảo vệ
- Khu vực được quản trị và quản lý
- Đóng góp bền vững và hiệu quả vào việc bảo tồn nội vi đa dạng sinh học

- Có các chức năng và dịch vụ hệ sinh thái liên kết với các giá trị văn hóa, tinh thần, kinh tế xã hội và các giá trị khác có liên quan tại địa phương

Kiên Giang là tỉnh có đa dạng sinh học cao và có nhiều khu vực tiềm năng đáp ứng các tiêu chí để trở thành OECMs. Bên cạnh các hệ sinh thái trên cạn, các hệ sinh thái biển của Kiên Giang, đặc biệt là tại các khu vực đảo ven bờ. Tuy nhiên, phần lớn các khu vực này hiện đang chưa được quản lý và bảo vệ một cách chính thức. Do đó, rất cần tổng hợp, nghiên cứu về các khu

vực OECM tiềm năng tại khu vực ven biển và đảo tại tỉnh Kiên Giang và số hóa các lựa chọn OECMs tiềm năng trên bản đồ GIS.

PREAMBLE

All financial records and other relevant documents relevant to or pertaining to this Agreement may be subject to inspection and/or audit at the discretion of IUCN or of the Donor. The Consultant agrees to allow IUCN or Donor's auditor(s) access to such records during normal business hours and to allow interviews of any employees who might reasonably have information related to such records. In the event of inspection or audit, IUCN or Donor shall provide the Consultant reasonable prior written notice.

1.4 The Consultant shall not subcontract the Services to third parties without the prior written consent of IUCN. However, the Consultant may under its own responsibility use the services of others provided such services are of an auxiliary or clerical nature.

2. TERM

3. INDEPENDENT STATUS

3.1 The employees, directors or shareholders of the Consultant shall not be entitled to any pension, bonus or other fringe benefits from IUCN.

3.3 No employee, director or other representative of the Consultant shall hold him or herself out or permit itself to be held out as having authority to do or say anything on behalf of or in the name of IUCN.

3.4 The Consultant shall be solely and exclusively liable for any and all taxes, levies or dues required to be paid in any of the countries where this Agreement applies, on any amounts paid to

the Consultant by IUCN and has sole responsibility for declaring such amounts to the relevant tax authorities.

4. OBLIGATIONS

4.1. The Consultant shall carry out its duties in an expert and diligent manner and to the best of its ability and shall promptly and faithfully comply with all lawful and reasonable requests which may be made by the IUCN Contact Person.

4.2. The Consultant shall give written or oral advice or information regarding the execution of the Services as and when required by IUCN.

4.3. In the case of illness or accident or a case of Force Majeure as described under clause 16.3 preventing the Key Personnel from performing the Services, the Consultant shall promptly notify IUCN in writing of impediment.

5. REMUNERATION

7.2 The Consultant warrants that it has obtained the assignment of all Results and Intellectual Property rights pertaining to the Results from his employees (including without limitation the Key Personnel).

7.3 The Consultant shall maintain at its sole expense liability and any other relevant insurance covering the performance of this Agreement. IUCN may require the Consultant to provide a certificate of insurance evidencing such coverage.

13.3 The Consultant represents and warrants that there are no potential or actual conflicts of interests in relation to the implementation of this Agreement. If, during the course of this Agreement, the Consultant becomes aware of facts which constitute or may give rise to a conflict of interest, the Consultant shall promptly inform the IUCN Contact Person in clause 12.1 in writing, without

14.1 IUCN recommends the Consultant to apply non-discriminatory practices in terms of benefits and remuneration for both men and women employees in the performance of this Agreement.

15. PROCESSING OF PERSONAL DATA

15.1 Personal Data is any information relating to an identified or identifiable individual, unless otherwise defined under applicable law. The Parties commit themselves to respect applicable data protection laws and regulations and process Personal Data in accordance with the terms of this Agreement.

16.3.1 The performance of this Agreement by either Party is subject to acts of God, war, government regulations, epidemics, pandemics, disaster, strikes (excluding strikes of respective Parties' personnel), civil disorders, curtailment of transportation facilities, or other emergencies making it illegal or impossible for either Party to perform its obligations ("Force Majeure Event"). The Party subject to a Force Majeure Event shall promptly notify the other Party of the occurrence and particulars of such Force Majeure Event, including how it impacts the performance of its obligations under this Agreement. The Party so affected shall use diligent efforts to avoid or remove such causes of non or delayed performance as soon as is reasonably practicable.

16.3.2 This Agreement may be terminated unilaterally without compensation for any one or more of the foregoing reasons by written notice from one Party to the other.

16.3.3 Notwithstanding the above, the Parties may agree to a suspension or an extension of the Agreement as deemed appropriate. Upon termination of the Force Majeure Event, the performance of the suspended Services shall without delay recommence.

16.3.4 The Party subject to the Force Majeure Event shall not be liable to the other Party for any damages arising out of or relating to the suspension or termination of Services by reason of the occurrence of a Force Majeure Event, provided such Party complies with all the requirements under this article 16.3.

16.4 Effects of Termination

In the event of termination under this clause, IUCN shall pay the Consultant any outstanding Remuneration in respect of Services performed by the Consultant up until the effective date of termination, it being understood that the total amount payable by IUCN to the Consultant shall not

exceed the Remuneration stated in article 5 of the Agreement. The Consultant shall within thirty (30) days of termination, and at IUCN's request:

16.4.1 to the extent possible, complete the Services subject to the Remuneration made available until the date of termination and stop all ongoing activities;

16.4.2 refund to IUCN any advance payments received in excess of the total expenditure incurred as evidenced in the invoices submitted to IUCN,

16.4.3 reimburse IUCN for any expenditures made in breach of the terms of this Agreement; and

16.4.4 submit final technical and financial reports and any other materials, deliverables, works or other outputs created as at the date of termination under this Agreement.

17. APPLICABLE LAW AND DISPUTE RESOLUTION

17.1 The performance and interpretation of this Agreement will be subject exclusively to the laws of Switzerland, excluding its conflict of laws principles.

17.2 Any dispute arising out of or in relation with this Agreement that cannot be resolved amicably by the Parties or by way of mediation shall be submitted to the competent courts of Lausanne, Switzerland.

18. GENERAL PROVISIONS

18.1 This Agreement is the complete understanding between IUCN and the Consultant and replaces all other agreements and understandings in reference to the subject matter of this Agreement.

18.2 Any modification or amendment of this Agreement shall be in writing and shall become effective if and when signed by both Parties.

18.3 This Consultancy Agreement is non-exclusive. IUCN is free to consult other experts in the Consultant's field of specialization.

18.4 This Agreement is personal to IUCN and the Consultant, and neither Party may sell, assign or transfer any duties, rights or interests created under this Agreement without the prior written consent of the other.

18.5 Either Party waives all and any rights of set-off against any payments due hereunder and agrees to pay all sums due hereunder regardless of any set-off or cross claim.

18.6 All provisions that logically ought to survive termination of this Agreement shall survive.

This Agreement may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same Agreement. The Parties agree that the signed counterparts may be delivered by e-mail in a ".pdf" format data file or electronic signature (e.g., DocuSign or similar electronic signature technology) and thereafter maintained in electronic form, and that in this case such signature shall create a valid and binding obligation of the party executing with the same force and effect as if such ".pdf" or electronic signature page were an original thereof.
