Job Details

Type: Full time employee, non-permanent, time-duration.

Start Date: Ideally, candidates available to start September 16, 2024.

Duration: From September 16, 2024 to March 31, 2025 with potential for extension.

Compensation: Employees will serve a probationary period of 675 working hours. During the probationary period the rate of pay is \$21.40 per hour. After successful completion of the probationary period the hourly rate of pay increases to \$23.60 per hour. Employees receive a monthly cellphone allowance and have the ability to influence a flexible schedule.

Complexity and Scope of the position

Under the direct supervision of the Restoration Field Technician Supervisor, management from the Operations Manager, and the mentorship from the Program Director, the Restoration Field Technician will work together as a team to accomplish the goals and activities of the FVWC Watershed Programs.
