## **Job Description**

# **Overall purpose**

The Project Assistant WASH (PA WASH) will enable local stakeholders, including factory workers, officials and communities, to participate in the project, assisting them to raise and analyse the critical issues related to WASH which impact their health. The PA-WASH will support to implement high quality programme interventions, focusing on the WASH needs of the factory workers in the targeted communities. The PA-WASH will provide support at community and factory level, to help project activities to be effectively implemented within the established timeframes. S/he will also regularly and directly interact with the targeted groups and maintain coordination and liaison with all the concerned stakeholders.

In addition, he/she will provide his/her full support to other project activities in which he/she is asked to engage and at all times adhere to WSUP's core values, Business Ethics, gender sensitivity and diversity activities according to the project and mission needs.

### **Main Responsibilities and Tasks**

- 1. Building capacity of Community Based Organizations (CBOs), Infrastructure Implementation Committee (IICs), users for sustainable WASH facilities in the LICs
  - Provide Assistance in developing Community Action Plan (CAP) to improve WASH situation:
  - Process the formation and activation of CBOs to improve WASH facilities in the LICs
  - Explain guidance to CBOs and Community members to assess the WASH needs of the LIC people and develop CAP and notify Supervisor
  - Attend monthly CBO Meetings:
    - Provide guidance to organize and hold effective meetings of CBOs
    - Conduct discussions on WASH related problems being encountered by the communities and report back to Supervision Engineer on recommendations made by CBO members to overcome these problems
    - Review the agenda related to CAP. Facilitate the process to address the problems by the CBOs/IICs
  - Organize capacity development training
    - Conduct session in developing the capacity of CBOs to oversee the facilities and hygiene practices in the community
    - Scheduling Workshop/ Training / Orientation session at community and factory level

## 2. Selection and Implementation of Infrastructure activities

#### • Scheme selection:

PA-WASH will support to select and implement the WASH Infrastructure activities, such as construction of toilet blocks, in the LICs as follows:

- Collect data for the feasibility assessment in terms of social aspect in the community.
- Submit the required papers to concerned department/person for obtaining no objection certificate against each scheme

- Conduct 'pre-measurement' and 'environmental assessment': Conduct "pre-measurement" and "environmental assessment" under the guidance of Supervision Engineer
- Formation and training of Infrastructure Implementation Committee (IIC): With Field Engineer, engage community members to form IIC, make agreements and arrange training for the IIC
- Observe progress of scheme:
   Pay routine visit to observe progress of schemes and provide feedback to the IIC and CBO with suggestions
- 3. Mobilize CBOs, community members and users to be more responsive to the WASH needs of the urban poor
  - Organizing day events at the community level:
     Organizing/observing different day events (Global Handwashing Day, Menstrual
     Hygiene Day, World Water Day and World Toilet Day) at the community level along
     with CBOs.
- 4. Information Management and Coordination
  - Sample Data collection:
     Each PA-WASH is required to collect basic data on progress of activities to complete reports on a monthly basis
  - Submission of monthly 'Progress Monitoring' sheet which measures project activities against the project plan:
    - Completed on a monthly basis and submitted to PO-WASH.
  - Attend relevant staff meetings
