In the context of the European Green Deal, our mission is to contribute to the implementation and development of EU water legislation and policy with a view to supporting the achievement of good status of EU waters, enhancing water resilience, reuse and the water/energy efficiency nexus, and the management of flood risk in the EU. To this end we:

- Monitor, assess and facilitate better implementation (including when necessary help with enforcing compliance) of the Water Framework Directive (WFD), its daughter Directives on Groundwater, Priority Substances (EQS) and the Floods Directive (FD); develop secondary legislation.
- Manage and steer the work under the Common Implementation Strategy of the WFD and FD, a participatory process involving stakeholders, Member States; candidate, EEA and EFTA countries to improve understanding, encourage best practice and facilitate better implementation of the above Directives.
- Monitor and address specific water issues at horizontal and country-specific level as appropriate.

Contribute to the integration of EU water legislation and policy objectives into other EU policies including agriculture, nature, climate action, cohesion, energy, transport, maritime, research, disaster risk prevention and others; we also support Member States with the economic aspects of water management and monitor financing possibilities, including relevant EU funds and other instruments.

- Evaluate and further develop existing EU water legislation.
- Support preparations for the application of the new Water Reuse Regulation in Member States.
- Follow-up on the water-related actions and targets of the Green Deal initiatives and develop and manage water policy initiatives, including in relation to water quantity management; related issues such as the Water Information System for Europe (WISE), a strategic approach to pharmaceuticals in the environment, and others.
- Contribute to sound water management in river basins shared by the EU and third countries; represent the EU in international river commissions (Rhine and Danube); contribute to water-related international co-operation activities.

We are service oriented and committed to work cooperatively with all internal and external stakeholders to find constructive and operational solutions for the challenges faced by EU waters, situated in the overall context of protecting, preserving and improving the environment for present and future generations, and promoting sustainable development (especially Sustainable Development Goal 6 'clean water and sanitation').
