The Government of the Republic of Zambia (GRZ) has received financing from the African Development Fund (ADF) towards the cost of the 'Improving Access and Strengthening Innovation for Water, Sanitation and Hygiene in Kabwe Town and Bauleni Township' (hereinafter referred to as the "Project") and intends to apply part of the agreed amount of this loan to payments under the individual contracts for the **Water & Sanitation Engineer**.

2. The Water & Sanitation Engineer will assist in providing engineering input to the Project Implementation Unit and will be responsible for the day-to-day implementation of the project. She/he will be supported by the internal structures of Lukanga Water Supply & Sanitation Company Limited, Lusaka Water Supply & Sanitation Company as well as the Design Review Consultants who will be engaged to carry out the design review of selected and agreed water treatment and distribution centres, tertiary pipelines, preparation of preliminary designs, detailed designs of selected treatment and distribution centres, distribution networks and a Faecal Sludge Treatment Unit (50,000 persons capacity).

3. Lukanga Water Supply & Sanitation Company Limited (LgWSC), now invites eligible candidates to indicate their interest in providing services of a water and sanitation engineer as part of the Project Implementation Team (PIT). Interested candidates must provide information indicating that they are qualified to perform the required services (cover letter, required qualifications, curriculum vitae, description of similar assignments undertaken, experience in similar conditions, availability of appropriate skills). Applicants must have minimum of Bachelor's Degree in Civil Engineering, Hydraulics, Sanitary, water services management or related field and a Master's Degree in project and contract management, utility management,

water sector reform or related field. General post-graduation experience of at least ten (10) years five (5) of which should be specific experience in water and sanitation sector; experience in project or contract management administration is a plus

4. The scope of work for the individual consultant includes but not limited to the following
  - a) The Engineer will assist in undertaking planning activities including preparation of reports thereof on water supply and sanitation;
  - b) Contribute to review of designs of water supply and other hydraulic systems including production of drawings and specifications, bill of quantities, participating in supervision of construction of water supply projects and other hydraulic investments;
  - c) Assisting the Project Manager in the review of invoices, payment certificates and other data that may be needed for financial management and reporting;
  - d) Verify all Consultant's and Contractor's claims for payment;
  - e) Ensure that reports at all stages are prepared in accordance with the requirements of the AfDB;
  - f) Assist coordinate all PIT activities with those of the supervision consultant, civil works contractor and all other studies and activities.
  - g) Assist coordinate, supervise, monitor the planning and implementation of all the activities under the project and ensure that they are executed in accordance the Loan Agreement with AfDB and Project Appraisal Report;
  - h) Assist coordinate the process of procurement, sub-project supervision at utility level;
  - i) Attend all co-ordination meetings with the consultants and contractors to discuss progress, and to contribute to deriving suitable remedial action where necessary to address issues arising;
  - j) Ensure preparation of quarterly progress reports for submission to the Project Manager;
  - k) Assist prepare the Completion Report at the end of activities for submission to the Government and the Bank and

The contract will be for a duration of 36 months subject to satisfactory yearly performance. The place for the assignment is Kabwe Town.
