Restoration Field Technician

Complexity and Scope of the position

Under the direct supervision and management of the Operations Manager, and the mentorship from the Director of Operations, the Restoration Field Technician will work with the FVWC field team to accomplish the goals and activities of the FVWC Watershed Programs.

Key Responsibilities	Tasks and Responsibilities Include:
Operations (>95 %)	FIELD SUPPORT – Tasks may include: <ul style="list-style-type: none"> • Harvesting and planting live stakes and whips willow for FVWC plantings. • Assistance with site preparation work including mechanical invasive plant control, seeding, and mulching. • Assistance with plant layout for volunteer plantings • Planting trees and shrubs and installing beaver guards on sites during/after volunteer plantings. • Ongoing maintenance work including mechanical removal of invasive plants, herbivory guard repair, planting, irrigation of plants, integrated pest-management techniques. • Water quality, fish and amphibian monitoring, • Mapping of watercourses, wetlands and riparian areas. • Ensuring proper use, care and storage of FVWC field equipment. • invertebrate sampling. • Taking photos before and after documenting each site. • Ensuring proper use, care and storage of FVWC field equipment. • Other tasks as assigned. • Maintaining FVWC's Ethical and Professional code of conduct. • Maintaining FVWC's Health and Safety requirements.

<ul style="list-style-type: none"> • Outside – Field Work. Hands-on, involves physical exertion -the ability to lift 50lbs, squatting, bending, extended time walking and standing. May be exposed to a wide range of weather conditions including heat, cold, wind and/or rain. This position requires you to operate equipment such as gas-powered hand tools. This position requires that you wear protective attire such as work gloves, hats, safety vests and footwear to protect yourself. *Training and protective equipment is provided by the employer.*
