Project Background

In order to enhance access to water, sanitation and hygiene (WASH) services in line with NTS-2, UNICEF is supporting the Government of Rwanda in the implementation of WASH interventions aimed at strengthening policy and institutional framework; provision of WASH services in communities, schools and health centres; hygiene and sanitation promotion; capacity building for sustainable operation and maintenance at the national and sub-national levels; climate resilient WASH programming, and emergency preparedness and response. In this regard, expressions of interests (EOI) are solicited from national and international NGOs having relevant expertise and experience for prospective partnership with UNICEF Rwanda for implementation of the above-mentioned WASH interventions. Interested NGOs are requested to submit the signed EOI (attached as Annex-1) and the completed EOI form (attached as Annex-2). The NGOs may indicate their interest in implementation of the interventions relating to one or more of the "areas of specialisation" listed under No. 4 above. Please note that this is not a request for proposals. Subject to availability of funds and needs, only short-listed NGO(s) would be contacted for submission of proposals in line with UNICEF procedures. Please also note that this EOI does not entail any commitment on the part of UNICEF.
